



# ISI Tuition Discount Policy

---

Islamic School of Irving provides multiple ways to discounts for the families to make tuition more affordable.

## Siblings Discount:

### Objective:

This Sibling Discount Policy is designed to provide a financial incentive to families enrolling multiple children in Islamic School of Irving. The policy aims to acknowledge and appreciate the commitment of families choosing our institution for the education of their children.

### Eligibility:

The Sibling Discount is applicable to families with two or more children simultaneously enrolled in the following programs.

- Full-time students at ISI in grades Pre-K 3 through 12
- Tanzeel full-time Hifz program
- Alimiyah full-time

To qualify for the discount, all siblings must be enrolled concurrently and maintain full-time student status.

# Discount Structure:

Tuition Discount Table

- The tuition discounts are not stackable, it means only one discount applies.
- \*\*The discount shall be calculated based on the minimum annual tuition among the siblings, the other student’s tuition is calculated at respective full annual tuition rates.
- Once the discount is determined, the discount amount is evenly distributed among all the siblings' tuition plans.
- The discount is available to the tuition fee only and does not extend to other fees or expenses associated with the school attendance.
- In case of changes in the enrollment status of any sibling (e.g., withdrawal, part-time enrollment), the Sibling Discount may be adjusted or discontinued based on the current enrollment status of the siblings.

# Application Process:

Families must inform the school's admissions office of the intention to enroll multiple siblings concurrently. The Sibling Discount will be automatically applied during the tuition fee assessment for eligible families.

## Review and Amendment:

This Sibling Discount Policy will be subject to periodic review, and the school reserves the right to amend or terminate the policy at its discretion. Any changes to the policy will be communicated to affected families in advance.

## Employee Discount

### Eligibility:

The full time employees of Islamic School of Irving and Tanzeel Academy are qualified for the tuition discount for their children who are enrolled full time at Islamic School of Irving or Tanzeel Academy.

### Discount Structure:

The tuition discount is 50% of the annual tuition fee. This discount can be combined with the sibling discount and will be applied **after** the sibling discount is applied.

**Example:** If a full time ISI teacher has 3 kids each enrolled full time at ISI with a total annual tuition fee of \$18000.

1. Third child discount of \$2500 will be applied first to bring the tuition to \$15500
2. A 50% employee discount is applied to come to the final tuition of \$7750.

In case of changes in the employment status of (e.g., termination of employment, part-time employment etc), the Employee Discount may be adjusted or discontinued.
